

LAWS OF NEW YORK.—By Authority

CHAPTER 159

AN ACT to incorporate the Women's League of United Synagogue of America, an association for promoting, in affiliation with the United Synagogue of America, traditional Judaism

Became a law March 27, 1931, with the approval of the Governor. Passed, three-fifths being present

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Silverman and Rose Goldstein, and their associates and successors, are hereby constituted a body corporate in perpetuity under the name of the Women's League of United Synagogue of America, and by said name shall possess all the powers which by the general corporation law and membership corporations law are conferred upon non-stock corporations, and shall be capable of taking, holding and acquiring by deed, gift, purchase, bequest, devise or by judicial order or decree, any estate, real or personal, in trust or otherwise, which shall be necessary or useful for the purposes and uses of the corporation. Said corporation, hereby created, shall, however, be subject to all of the provisions of the membership corporations law so far as the same are applicable and not inconsistent with the provisions of this act.

§ 2. The objects of said corporation shall be:

The advancement of traditional Judaism by:

- (a) Furthering Jewish education among women.
- (b) Creating and fostering Jewish sentiment in the home.
- (c) Promoting the observance of Sabbath and festivals, home ceremonials and Jewish dietary laws.
- (d) Strengthening generally the religious institution of the community.

§ 3. The business affairs of said corporation shall be conducted by a board of sixty-six members, and the persons named in the first

section of this act as incorporators, shall constitute the first executive council of said corporation and shall hold office until the installation of their successors who shall be elected at the times and in the manner provided by the by-laws to be adopted by the said executive council. The number of members constituting the executive council may be increased or decreased at any annual election, in such manner as may be provided by the by-laws duly adopted.

§ 4. The members of said corporation shall consist of the persons who shall be designated and chosen as delegates to the convention of said corporation by such methods or method, and by such organizations, societies, nominating and constituent bodies as shall be provided in by-laws to be adopted by the executive council, such by-laws, however, being subject to alteration, revision or amendment, at any regular convention of such corporation or at a special convention called for such purpose, provided that thirty days' notice be given of the proposed change.

§ 5. This act shall take effect immediately.
